# Intermediate Electronic Fetal Heart Monitoring Course

## COURSE DESCRIPTION

The Intermediate Course is a two-day standardized course focusing on the application of essential fetal heart monitoring knowledge and skills in intrapartum nursing practice. The Intermediate Course also can be used as a competency assessment to validate the knowledge and skills of experienced nurses.

During the didactic session participants analyze case scenarios using key physiologic principles, interpret tracings, identify nursing interventions, and demonstrate verbal and written communication skills. During the skill sessions participants demonstrate, practice, and are tested on the following skills: auscultation, Leopold's Maneuvers, placement of an intrauterine pressure catheter and spiral electrode, interpretation of tracings, identification of indicated nursing interventions, and communication and documentation.

Successful completion of written examinations and performance of skills evaluations are requirements for completing the program and earning competency validation.

### The Intermediate Course is designed for:

- > Registered nurses with a minimum of six months clinical nursing experience using fetal heart monitoring technology in an intrapartum setting.
- > Registered nurses that have a basic knowledge and related skills in these areas:
  - Maternal physiologic changes of pregnancy.
  - Fetal growth and development.
  - Methods of fetal monitoring.
  - Preparation of patient for set-up and initiation of external or internal fetal monitoring.
  - Obtaining and maintaining tracings that document fetal heart rate and uterine contractions.
  - Interpretation of uterine contraction frequency, duration, and baseline resting tone.
  - Identification of the baseline fetal heart rate, variability, and deviations.
  - Indicated clinical interventions.
  - Communication and documentation standards.

## OBJECTIVES

At the completion of this program, each participant will be able to:

- Demonstrate the decision-making process necessary for the proper selection and verification of fetal heart monitoring (FHM) techniques.
- Analyze fetal heart rate patterns and their implications for fetal well-being.
- Correlate indicated clinical interventions with related maternal-fetal physiology.
- Describe the role and responsibility of the professional nurse in the use of FHM in intrapartum care.
- Simulate the psychomotor skills used in FHM.
- Communicate verbal and written data to verify accountability.

## ACCREDITATION

Participants who fully attend and participate in the workshop earn 18.3 contact hours of continuing education credit or 15.25 CMEs. No partial credit is awarded. AWHONN is accredited as a provider of continuing education in nursing by the ANCC's Commission on Accreditation.
